Public Hearing Ordinance #002-2021- Amending Chapter 190 of the Code of Hammonton

AN ORDINANCE TO AMEND CHAPTER 190 OF THE GENERAL ORDINANCES OF THE TOWN OF HAMMONTON

BE IT ORDAINED by the Mayor and Council of the Town of Hammonton, County of Atlantic and State of New Jersey as follows:

1. Chapter 190, Article I, Section 3, the title of the Section is changed to read:

§190-3. Noise prohibited at certain times.

2. Chapter 190, Article I, is amended to add Section 190-7 which states:

§190-7. Noise prohibited at all times. Notwithstanding, §190-3, it shall be unlawful for any person to make, continue or use to be made or continued any loud or disturbing noise that significantly interferes with the public peace, the public comfort or the public convenience of others within the Town of Hammonton, at any time. It shall be prima facie evidence of a violation of this Section if the noise is plainly audible at a distance of 1,320 feet (0.25 miles) from the building, structure, vehicle or place in which the noise is emanating. The exceptions set forth in §190-5 shall be applicable to this §190-7. Any person who shall violate this §190-7 shall be subject to the violations and penalties set forth in §190-6.

BE IT FURTHER ORDAINED, that if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the Courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provision so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

BE IT FURTHER ORDAINED, that any Ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict; and

BE IT FURTHER ORDAINED, that this Ordinance shall take effect following adoption and approval in the time and manner prescribed by law.

PWM REPORT

Radon Awareness Program, Test Kits

The Town received an approval on 01/19/2021 of a \$2,000 grant to allow for the purchase, distribution and testing of radon test kits. We sent out price quote requests to three (3) different certified testing labs for the delivery, testing and recording of results. The Town will be able to purchase and distribute 100 test kits to Town residents at no cost. The low-price quote was received from Certified Environmental Contractors LLC from Farmington, NJ for a cost of \$1,480.00 for 100 test kits. Once the test kits are received we will place a notice in the newspaper and on the Town website related to instructions for pick-up, testing and shipment to the lab. We will seek reimbursement of project costs from the NJDEP, Radon Awareness Unit.

Resolution #033-2021- Ratify and approving Settlement Agreement from 2017

Resolution Ratifying and Approving Settlement

WHEREAS, the Town Council of the Town of Hammonton adopted Resolution #053-2017 at its meeting on April 10, 2017; and

WHEREAS, the Government Workers Union (the "GWU") filed an unfair practice charge challenging certain provisions of Resolution #053-2017; and

WHEREAS, representatives of the Town of Hammonton (the "Town") and the GWU participated in a conference at the Public Employment Relations Commission on June 15, 2017 in an effort to resolve the allegations of the unfair practice charge, which charge the Town denied; and

WHEREAS, the Town and the GWU agreed to terms and conditions that resulted in the GWU agreeing to withdraw its unfair practice charge and the Town agreeing to certain procedures to be followed in the event of predictable emergent events, which terms and conditions were reduced to writing and signed by the representatives of the parties (the "Settlement Agreement"), a copy of which is attached hereto; and

WHEREAS, as part of the Settlement Agreement the Town agreed that the second paragraph of Resolution #053-2017 was rescinded and subject to labor negotiations; and

WHEREAS, the Town has followed the procedures set forth in the Settlement Agreement since June 15, 2017 for predictable emergent events covered by the terms of the Settlement Agreement and has not utilized the procedures set forth in the second paragraph of Resolution #053-2017 since June 15, 2017; and

WHEREAS, the terms of the Settlement Agreement are acceptable to the Mayor and Town Council of the Town; and

WHEREAS, it is not clear from a review of the Town's records and meeting minutes whether the Mayor and Town Council formally approved the Settlement Agreement; and

WHEREAS, it is in the best interests of the Town to eliminate any doubt about whether formal action was taken to approve the Settlement Agreement.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Town of Hammonton that the Settlement Agreement is hereby ratified and approved in its entirety effective as of June 15, 2017 and Resolution #053-2017 shall be considered amended as provided in the Settlement Agreement.
