DISCUSSION

Discussion regarding the state's approval of recreational marijuana and how that would impact the Town of Hammonton. There are six market place classes of licensed businesses including: Cultivating – growing, Manufacturing – preparation & packaging of cannabis items, Wholesale – obtaining and selling of cannabis items to later resale by other licensees, Distribution – transportation of cannabis products, Retailer – locations at which cannabis items and related supplies are sold to consumers and Delivery – courier service for consumer purchases that are fulfilled by a licensed cannabis retailer and delivered to the purchaser. Each municipality is given 180 days to decide what services they will allow in their town and where. However, the state has not ironed out the particulars of each of these classes of licenses and may not until the deadline of August 20, 2021. The Town of Hammonton wishes to say no to all at this time until we see what the state decides are the parameters of each class. When we say no we can change to yes at any time, but if we say yes we are locked in for 5 yrs. Town Council is asking for the Board's support of this decision. We will revisit after Gov. Murphy provides guidelines.
